### **COMMISSION MEETING, 9:00 A.M.**

Commission President Riordan called the Commission meeting to order at 9:12 a.m. Commissioners Riordan, Rubalcava, Khero, Knaan and Brunson were present.

#### ADMINISTRATIVE APPEAL HEARING

1. Appeal of the General Manager's Decision in Barking Dog Case –DA 04568 (WV)

Mr. Howard Ellis, Management Assistant, introduced the facts of the case and the actions of the General Manager to revoke the dog's license in a dangerous animal case. Mr. Charles Liplow, the complaining party failed to appear. Ms. Elisa Rodriguez and Ms. Cynthia Puno presented facts consistent in support of their appeal. They no longer have custody of the dog-named Cesca (License No. LO4-042832). They have complied with the previous Terms and Conditions set-forth by the Department. Additionally, the dog owners have installed/repaired fencing on their property. Ms. Puno and Rodriguez reported they had spent approximately \$1,400 in training their dog. A motion to overturn the Decision of the General Manager to suspend the license was made by Commissioner Knaan and seconded by Commissioner Khero. The motion passed 5-0 to overturn the General Manager's recommendation to suspend the dog license.

Appeal of the General Manager's Decision in Barking Dog Case –BD 04569 (WV)

Mr. Howard Ellis, Management Assistant, introduced the facts of the case and the actions of the General Manager in a barking dog case. The dog Mr. Karsh, left the meeting prior to the case being called and did not appear on his behalf. The Complainants, Robert and Diane Winters alleged excessive barking. A motion by Commissioner Brunson to set aside the General Managers Report and reinstate the dog's license, with conditions was made and seconded by Commissioner Rubalcava. The motion to affirm the decision of the General Manager to reinstate the license with previously issued conditions along with training and maintaining the dog indoors between the hours of 10:00 P.M. and 7:00 A.M. was approved 5-0

Appeal of the General Manager's Decision in Barking Dog Case –BD 04714 (SL)

Mr. Howard Ellis, Management Assistant, introduced the facts of the case and the actions of the General Manager in a barking dog case. The Complainants, Cherell Chappell and Tommy Watson alleged excessive barking and failure to adhere to the terms and conditions previously issued. The dog's owner Mr. Steven Boston, presented evidence that he had purchased anti-barking collars but they did not work. Commissioner Rubalcava made a motion to uphold the General Manager's decision to revoke the dog's license. Commissioner Khero seconded the motion. The motion was approved 3-2 with Commissioners
