#### **ADMINISTRATIVE APPEAL HEARING**

Commissioner Ramsayer made a motion to uphold the Terms and Conditions, with modifications to include additional training, bark collars, boarding of dogs when out of town, maintain dogs in the residence. Commissioner Secunda seconded the motion and the motion passed 3-0.

#### 2. DISCUSSION ITEMS

A. Discussion regarding posting of informational signs throughout the Shelters and other public areas

General Manager Barnette commented that groups including representatives from Councilman's Koretz office have been working on signage that will be funded by Found Animal Foundation. Jim Bickhart of the mayor's office indicated that banners for lampposts will be ready by summer. Banners will

be hung on lampposts leading up to the shelters. Some banners will be hung around DMV offices to encourage drivers to purchase "pet lovers license plates". Signs in Santee alley and other high traffic areas, warning shoppers about purchasing animals on the street and shelter signage regarding turning in pets were also discussed. Funding sources for signage and the cost of posting the signs was also discussed. It was indicated by Mr. Bickhart that a funding discussion was before the City Council.

She recommended that a cap for administrative actions be placed in the motion. It was commented that in the three years the deduction was in place, no administrative costs were assessed against the fund.

#### **Personnel Consolidations**

Several Unions are voting on settlement that would end furloughs for our ACTs and officers

96 Cats from the possible cruelty case have gone to a cat rescue taking our population at NE Mission back to around 50 which is what it usually is.

**NE Mission Shelter scheduled to close at the end of the fiscal year**. I am hopeful that a private group will be allowed to operate the shelter as an adoption agency and we will continue to provide all field services to that district.

#### **South LA Shelter Update:**

Linda Gordon, Allan Kawaguchi and I attended the regular meeting of the Administrative Oversight Committee for Bond F. The Committee is Chaired by the CAO's Office and includes representative from the Mayor's Office, Fire Department, Chief Legislative Analyst and Police Department. Allan Kawaguchi, BOE is staff to that Committee and reported on the changes to the new South LA animal shelter that have been requested by Commission President Ramsayer and Commission Vice President Secunda.

The Oversight Committee authorized BOE to move forward on any changes that

- 1.) make minimal changes in the approved project budget, and
- 2.) will not delay the completion of the project.

Also, I attended a meeting with City Attorney Pete Echeverria, Deborah Weintraub, Mandana Khatibshahidi, Ramon Soto, Allan Kawaguchi, Linda Gordon and CM Parks Chief of Staff, Mike Hernandez. The purpose of that meeting was to discuss whether or not the land across the street from the shelter can be purchased and developed with Prop F money for the proposed annex for dog exercise and socialization. No decision was reached. Mr. Echeverria does not feel that it is appropriate under the current proposal. Deborah Weintraub has some ideas for a way to study the project and compare it to the other shelter facilities to determine if it meets or exceeds

space usage for dog exercise at other facilities based on size of entire project/number of dog runs. There will be subsequent meetings on this topic.
