UPDATES REQUESTED BY COMMISSION June 28, 2011

- Where we are with the ordinance to make it illegal to buy animals in Santee Alley,
 Venice Beach, etc. And an update on the signage that should go up as soon as this is done
 - The City Attorney's Office submitted a draft ordinance to The Public Safety Committee on 6-13-11.
- New South LA Shelter were the changes we requested accommodated?

The Proposition F, Administrative Oversight Committee approved proceeding with these modifications:

- Installation of conduit, for closed-circuit cameras, for the dog isolation and dog quarantine areas;
- o Soundproof walls of the small animal holding room;
- o Re-purpose the cat nursery to a community cat room;
- o Re-purpose the exotic and reptile room to become the cat nursery;
- Re-purpose the south cat get acquainted room to become the exotic and reptile room.

Ventilation system: For that-the information is that each animal-keeping area is supplied with 100% fresh air, no recirculation of air, with 16 air exchanges per hour. (You can contrast that with most hospital rooms are 50% fresh air and 12 air exchanges per hour.)

And one last thing is that they wanted a walkway from the employee parking area to the kennels, so wild animals do not have to be walked thru the kennels - There is one there.

• Bail increase situation

 Ross Pool submitted a draft transmittal letter to Dov last week. Dov advised he would be consulting with the Criminal Division for comment.

• On-line licensing

- (NOTE: We currently have on-line licensing for renewing licenses. In FY10-11, we sold a little more than 2,000 renewal licenses through our on-line system.)
 Our Systems Staff have been working on on-line licensing for new licenses. However, the Omnibus Licensing Ordinance must pass Council to enable the Department to do new licenses on-line. We are hopeful the ordinance amendments will be passed by Council sometime this summer with on-line licensing for new licenses ready 30 days after Council passage.
- One section in the Omnibus Lic Ord (Sec. 53.15(d)) allows us to determine in what form/format we will accept a rabies vac cert. Right now, we have to have a rabies cert in paper form signed by a vet. Once it passes, we will be able to accept it in any fashion you deem appropriate and that enables us to do new licensing on-line. (We changed the State Law so now we need to adopt this into our code.)
- Another section 53.15(a), provides the same language as we are proposing for the licensing part (it states "in a manner that the prescribed by the Department") for allowing flexibility on what form we can accept s/n certs.

Are the officers in the field now equipped with mobile credit card readers (I remember Found Animals saying they would donate)

- No. More than a year ago, Found Animals Foundation offered to provide mobile credit card readers for our Canvassing Team of 8 individuals. Our Canvassing Team was laid off a year ago. If/when we are able to hire Officers to do license canvassing or form a team for license canvassing, we will approach Found Animals for credit card readers at that time.
- Prior to implementation, we will also have to discuss this process and gain approval from the Treasurer's Office, insure our financial vendor (Wells Fargo) can accept the readers on their system, and develop an auditing process and procedure that meets City guidelines.

• Budget and staffing concerns

BUDGET: Our FY11-12 budget is approximately \$750,000 short in our salaries account. This deficit is due to assuming furloughs of 36/26 days per employee would be in effect on July 1, 2011. Effective July 1, only RVT and certain Admin Staff (Systems, Accounting and HR, for example) are on mandatory 26 day furloughs. There is also a small salary increase (1.75%) that was not included in the draft budget. We are working with CAO to resolve the shortfall.

- STAFFING: We are critically short in RVT, ACT and ACO classifications.
 Please also keep in mind that through the Budget Process this year, all vacant positions were swept leaving us with minimal staffing levels.
 - RVTs— Due to attrition, we are short 5 full time RVTs. Additionally, we have 2 RVTs that are on long term leave; one is not expected back the balance of this calendar year. That leaves us with a total of 19 full time RVTs on duty to staff 7 shelters with a current shortage of 7 full time positions.

Through the managed hiring process, we have been approved to fill 4 full time RVT positions with 4 part time RVT positions. We hired 2 part time RVTs. One part time RVT is on board and working. The second part time RVT began work but was put off duty. We are working with HR on her case. We are in the hiring process for the remaining 2 (possibly 3) part time RVTs. We are also lobbying to convert 1 ACT to a full time RVT.

- ACTs Due to attrition, we are short 3 ACT positions. We have applied to Managed Hiring for permission to hire 3 ACTs and are awaiting their decision. NOTE: We have an additional11 ACTs off duty on Worker's Comp injuries, FMLA or Admin Leave, plus another 7 on light duty due to injuries.
- ACOs We are short 1 ACO I position and 2 ACO II positions. We have applied to Managed Hiring for permission to hire and are awaiting their decision. NOTE: We have an additional 3 ACOs off duty on Worker's Comp injuries.
