AGENDAS - The Board of Animal Services Commissioners (Board) meets regularly every second (2nd) and fourth (4th) Tuesday of each month at 10:00 A.M. Regular Meetings are held at City Hall, 200 North Spring Street, Room 1060, in Los Angeles, CA 90012. Evening Meetings are held in various locations throughout the City, from 7:00 to approximately 9:30 P.M. The agendas for Board meetings contain a brief general description of those items to be considered at the meetings. Board Agendas are available at the Department of Animal Services (Department), Administrative Division, 221 North Figueroa Street, 6th Floor, Suite 600, Los Angeles, CA 90012. Board Agendas may also be viewed on the 2nd floor Public Bulletin Board in City Hall East, 200 North Main Street, Los Angeles, CA 90012. Internet users may also access copies of present and prior agenda items, copies of the Board Calendar, MP-3 audio files of meetings as well as electronic copies of approved minutes on the Department's World Wide Web Home Page site at <http://www.laanimalservices.com/CommissionAgendas.htm>

Three (3) members of the Board constitute a quorum for the transaction of business. Some items on the Agenda may be approved without any discussion.

The Board Secretary will announce the items to be considered by the Board. The Board will hear the presentation on the topic and gather additional information from Department Staff. Once presentations have finished, the Board President will ask if any Board Member or member of the public wishes to speak on one or more of these items. Each speaker called before the Commission will have one (1) minute to express their comments and concerns on matters placed on the agenda. (For certain agenda items, speakers will have two (2) minutes.)

PUBLIC INPUT AT BOARD MEETINGS – **Public Participation on Agenda Items.** Members of the public will have an opportunity to address the Board on agenda items after the item is called and before the Board takes action on the item, unless the opportunity for public participation on the item was previously provided to all interested members of the public at a public meeting of a Committee of the Board and the item has not substantially changed since the Committee heard the item. When speaking to an agenda item other than during Public Comment (see Public Comment below), the speaker shall limit his or her comments to the specific item under consideration (California Government Code, Section 54954.3).

Public Comment. The Board will provide an opportunity for public comment at every regular meeting of the Board. Members of the public may address the Board on any items within the subject matter jurisdiction of the Board as part of Public Comment.

Speaker Cards. Members of the public wishing to speak are to fill out one speaker card for each agenda item on which they wish to speak and present it to the Board secretary **before** the item is called.

Time Limit for Speakers. Speakers addressing the Board will be limited to one (1) minute of speaking time for each agenda item except during general public comment period which is limited to two (2) minutes per speaker. (For certain agenda items, speakers will have two (2) minutes each.). The Chairperson, with the approval of a majority of the Board, may for good cause extend any speaker's time by increments of up to one (1) minute.

Brown Act. These rules shall be interpreted in a manner that is consistent with the Ralph M. Brown Act, California Government Code Section § 54950 et seq.

STANDARDS OF CONDUCT. Speakers are expected to behave in an orderly manner and to refrain from personal attacks or use of profanity or language that may incite violence.

All persons present at Board meetings are expected to behave in an orderly manner and to refrain from disrupting the meeting, interfering with the rights of others to address the Board and/or interfering with the conduct of business by the Board.

In the event that any speaker does not comply with the foregoing requirements, or if a speaker does not address the specific item under consideration, the speaker may be ruled out of order, their speaking time forfeited and the Chairperson may call upon the next speaker.

The Board, by majority vote, may order the removal from the meeting of any speaker or audience member continuing to behave in a disruptive manner after being warned by the Chairperson regarding their behavior. Section 403 of the California Penal Code states as follows: "Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is not unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Section 18340 of the Elections Code, is guilty of a misdemeanor."

VOTING AND DISPOSITION OF ITEMS – Most items require a majority vote of the entire membership of the Board (3 members). When debate on an item is completed, the Board President will instruct the Secretary to "call the roll". Every member present must vote for or against each item; abstentions are not permitted unless there is a Conflict of Interest for which the Board member is obliged to abstain from voting. The Secretary will announce the votes on each item. Any member of the Board may move to "reconsider" any vote on any item on the agenda, except to adjourn, suspend the Rules, or where an intervening event has deprived the Board of jurisdiction, providing that said member originally voted on the prevailing side of the item. The motion to "reconsider" shall only be in order once during the meeting, and once during the next regular meeting. The member requesting reconsideration shall identify for all members present the Agenda number and subject matter previously voted upon. A motion to reconsider is not debatable and shall require an affirmative vote of three members of the Board.

When the Board has failed by sufficient votes to approve or reject an item, and has not lost jurisdiction over the matter, or has not caused it to be continued beyond the next regular meeting, the issue is again placed on the next agenda for the following meeting for the purpose of allowing the Board to again vote on the matter.

Meeting called to order at 10:06 a.m. Commissioners present were Gross, García, Dicker, Finsten and Wolfson. Also present from Los Angeles Animal Services (LAAS) Assistant General Manager (AGM) Dana Brown acting as Board Secretary and General Manager (GM) Brenda Barnette; and Assistant City Attorney (ACA) Dov Lesel.

Commissioner Gross opened the meeting, introduced staff and provided an overview of the meeting agenda.

I. **ADMINISTRATIVE APPEALS**

1. **Possible Dangerous Animal Case: DA 153077 WV**

Respondent: Janice Vanasco

South Los Angeles Animal Care and Control: Lieutenant Lorna Esparza

Complaining Witness: Kathryn Meisrow

The Respondent recounted the specifics of the incident including the fact that her dog was on an electronic leash. The Complaining Witness Kathryn Meisrow did not attend the hearing. **Commissioner Gross** reminded the respondent that electronic leashes are not legal in Los Angeles. The Respondent indicated that there was a hearing for which she was not properly notified so she was not in attendance. The Respondent indicated she filed a writ of mandate that resulted in a re-hearing of her case. **Commissioner Wolfson** reminded the Respondent to focus on the issues that will assist the Commission to make a decision. **Commissioner Gross** recounted the history of Notices to Comply issued to the Respondent regarding her dogs being off leash (electronic collar). Respondent acknowledged the history and stated that she believes her dogs are gentle and not dangerous. **Commissioner Garcia** mentioned the Respondent's lack of compliance despite being warned repeatedly. Respondent petitioned the Board for one more chance. **Commissioner Gross** reminded the Respondent that she was given several chances. **Commissioner Wolfson** stated there was no basis to overturn the Hearing Examiner's decision. **Commissioner Dicker** disagreed that the dogs are dangerous. **Commissioner Gross** clarified that the dogs were not deemed dangerous but the Respondent's license was revoked. **GM Barnett** confirmed the department may deem that a dog is not dangerous; rather, the owner is irresponsible. **Commissioner Dicker** opined that there is no basis to deem that the Respondent's dogs are dangerous. **ACA Lesel** further clarified that cases resulting in license revocation occur when the dog's owner is found to be incapable of confining or caring for the dog in a way that is safe for other

animals and the public, whether or not the dog is deemed dangerous. If the license is revoked and the dog is deemed not dangerous, the owner has the option of either keeping the dog under the condition that they remove it from the City of Los Angeles or surrendering the dog to the Department of Animal Services. The surrendered dog is then made available for adoption. **Commissioner Dicker** stated that his concern is that, if not adopted, the dogs could be euthanized. **ACA Lesel** confirmed that is true of any animal that is received by the Department. **Commissioner Gross** summarized that the sole purpose of this hearing is to review the Hearing Examiner's determination that the licenses should be revoked based on Respondent's failure to comply with numerous citations notifying her that the dogs must to be on a leash. **Commissioner Dicker** stated that the record supports that the Respondent is clearly an irresponsible dog owner. However, he prefers that the owner be afforded one more chance and opined that the dogs pose no danger to anyone except themselves if they get off-leash, and are hit by a car. **GM Barnette** cautioned that dogs running into traffic do pose a risk to people and to the animals. **AGM Brown** counseled the Board that if they remand the case back to the Hearing Examiner, and if the owner breaks the terms and conditions, the result remains a license revocation, leading to owner surrender or rehoming the animal outside of the City. **Commissioner Garcia** inquired if respondent is still using electric collars or if the dogs are now on leashes. Respondent's reply was inaudible. **Commissioner Wolfson** thanked Commissioner Dicker for his contributions to the conversation, and stated that the evidence in this case supports the Hearing Examiner's decision to revoke the license. He advised Commissioner Dicker that a motion can be made to remand the case the Hearing Examiner with terms and condition. If the motion fails then the Board would vote on upholding the General Manager's decision. **Commissioner Dicker** thanked Commissioner Wolfson for the information and laid out the terms and conditions that he wished imposed including, that the dogs be walked only one at a time while wearing an Easy Walk Harness tethered to a limited slip collar. **Commissioner Wolfson** stated that if Commissioner Dicker made a motion, he would second it, although he would vote against it.

Commissioner Dicker motioned to reverse the General Manager's decision and modify it with terms and conditions. **Commissioner Wolfson** seconded and the motion failed by a vote of 1-4.

Commissioner Wolfson expressed gratitude for the debate that took place and wished that there was more he could do as a Commissioner.

Commissioner Gross motioned to uphold the General Manager's decision. **Commissioner Garcia** seconded the motion and was approved by a vote of 4-1.

2. Possible Dangerous Animal Case: DA 171184 NC

Respondent: Robert Jesse Gamino

South Los Angeles Animal Care and Control: Lieutenant John Cessna

Complaining Witness: Song Nam An

Respondent Robert Jesse Gamino was not in attendance. **Commissioner Garcia** asked the Department if the responded planned on attending. **AGM Brown** replied that they expected the Respondent would attend since he had

requested for the hearing be scheduled as soon as possible. **GM Barnett** commented that local traffic was worse than usual. **Commissioner Garcia** asked the witnesses to restrict testimony to what was already provided for the Hearing Examiner's report. Testimony was provided by Witness Tracy Hughley and Complaining Witness Song Nam An. Ms. Hughley testified that she witnessed the attack on the Complaining Witness and that it was the third time that she had witnessed the Respondent's dog out and off-leash. **Commissioner Gross** asked Ms. Hughley for clarification because the report mentioned two dogs. Ms. Hughley confirmed that Respondent owns two dogs, both white Pit Bulls; one male "Rocco," and one female "Roxy". Ms. Hughley testified that the male dog carried out the attack. **Commissioner Garcia** asked Ms. Hughley if, out of the two white Pit Bulls mentioned in her declaration, she knows the difference between the two. Ms. Hughley testified that knows it was Rocco because it was the dog that attacked is a white male, not the female and not a grey and white dog, temporarily in the Respondent's care. Ms. Hughley added that other witnesses also confirmed that it was the male dog. She further testified that despite this and other incidents of the dogs getting out, Respondent still has not fixed the gate on his yard. **Commissioner Gross** asked Ms. Hughley if the respondent has taken any steps to secure his property. Ms. Hughley stated that as of the previous evening when she and her husband walked by the property, nothing changed. **Commissioner Wolfson** inquired if Rocco was impounded. Ms. Hughley and the Department confirmed that he was. Ms. Hughley stated that Respondent demonstrated that he is not a responsible dog owner and that he has no regard for the safety of his neighbors. **Commissioner Wolfson** suggested that, in the Respondent's absence, the Board focus on determining if the Hearing Officer's decision was reasonable, and if they have concerns to direct their questions to the witnesses. **Commissioner Garcia** stated the Hearing Examiner's report was not clear on who identified Rocco; a key piece of evidence that should be included. Ms. Hughley acknowledged that she did identify Rocco by his gender, breed, and appearance. Additionally, Ms. Hughley stated that she regularly walks her dog within view of Respondent's dogs and is familiar with both of the dogs. **Commissioner Garcia** stated that it is necessary for Hearing Examiners to always state in their reports specifically how the dogs were identified. Ms. Hughley added that the white female Pit Bull and a third smaller grey dog did not take part in the attack. **Commissioner Gross** asked the Complaining Witness Song Nam An about the cost of her medical bills. Ms. An stated veterinary expenses of approximately \$12,600 were incurred resulting from the fatal injuries her dog sustained in the attack. **Commissioner Gross** asked Ms. An if the Respondent has offered any sort of compensation. Mr. An replied that Respondent has not made any offer. The Board discussed lack of documentation regarding Respondent's dogs' rabies vaccination, spay/neuter status, lack of licensing, and owner's negligence, and lack of understanding the laws. **Commissioner Finsten** asked if the Respondent still has a dog in his possession. Ms. Hughley confirmed that she saw Roxy in Respondent's yard last week. **Commissioner Finsten** asked for clarification on if the Hearing Examiner's recommendation is that all dogs be removed. **Commissioner Gross** stated that Rocco would be declared a dangerous animal, the licenses for both dogs revoked, and the owner would not be allowed to own dogs. **ACA Lesel** confirmed that the Respondent would not be allowed to own dogs for the next three years. **Commissioner Garcia** added that Roxy would also be removed but she would not be declared a dangerous animal, and would be available for

adoption. **Commissioner Dicker** stated that he has no problem with the record. **Commissioner Wolfson** thanked Ms. An and Ms. Hughley for their testimony.

Commissioner Gross motioned to uphold the General Manager's decision. **Commissioners Dicker and Garcia**, and was approved by a unanimous vote of 5-0.

II. REGULAR COMMISSION MEETING

1. PUBLIC COMMENT

Phyllis Daugherty: Spoke about an incident where a person was attacked by a dog that was adopted from a City shelter after staff cautioned the adopter that the dog was dangerous, and is an example of why dangerous animals should not be available for adoption; briefly spoke about another dog attack that occurred in Bozeman, resulting in the victim's comatose state; spoke out against raising limits on the number of animals that can be legally owned. **Jeffrey Mausner:** Requested that the swamp coolers be repaired or misters installed in the dog kennels at the West Valley Shelter; spoke about the dangers of "sticker" plants in the dog play yards; suggested temporary cooling solutions for animal control trucks lacking air conditioning; asked that ACT's perform follow up evaluations on dogs brought in from the trucks after they've had a chance to acclimate; spoke about Phyllis Daugherty's article regarding dog thefts and recommendations to make it easier for owners to find missing dogs, free up space, and save animals' lives. **Theresa Brady:** Stated that she emailed the Department a video tape of the conditions of the rabbits' area at the West Valley Animal Shelter; acknowledged receipt of GM Barnett's reply via email advising that at end of this summer that area is scheduled for a \$25,000 renovation; contends that the hot conditions in the room must be resolved immediately; offered suggestions to improve air conditioning by adding a second electrical circuit; also recommended landscaping improvements

2. 3. COMMISSION BUSINESS

A. Approval of the Minutes for Meeting of June 13, 2017.

Commissioner Gross made a motion to approve the minutes. **Commissioner Garcia** seconded the motion and it was approved by a unanimous vote of 5-0.

4. ORAL REPORT OF THE GENERAL MANAGER

GM Barnette discussed the following:

- Update on preparations for the Fourth of July influx, which consistently averages 4,000 animals. In the preceding weekend, Pet Care Foundation hosted East Valley and West L.A. Shelters, completely underwriting adoption fees for dogs and cats. Press release to promote fostering and adoption was put out last week and will go out again this week; additional press release recommending pets be kept indoors during this period to prevent stress and loss. #4Days4Life foster program video on Department's Facebook page. Radio ad on KNX 1070 and spot on KTLA 5 promoting safety over the 4th of July, fostering, and adoption are scheduled for this week.
- Public Speaker Theresa Brady's suggestion of adding a second electrical circuit can be looked into.
- Addressed cooling solutions for the dog transport trucks; older models are equipped with air conditioning but it must be turned on, new models automatically turn on the air conditioning. Frozen water bottles placed in the holding units pose a risk to dogs that chew the bottles and ingest the pieces. Misters and air conditioning in the shelters seem functional. Shelter staff and volunteer hydration is also of concern.
- There is much interest in the position for Director of Volunteer Services, 10 job applications were received, and five of those applicants met the requirements in the job bulletin; interviews scheduled for next Friday.

Commissioner Gross inquired about press releases regarding protecting pets from hot weather. **GM Barnette** confirmed that the Department had put those out. **Commissioner Dicker** stated that providing large dogs with only frozen water bottles for cooling seems insufficient. **GM Barnett** clarified that the dogs are given ice and stated that it might be better to provide water frozen in bowls.

Public Comment:

Phyllis Daugherty: Cited San Diego's free microchipping program as a good example of 4th of July preparations.

Commissioner Gross inquired about the license renewal recommendation that went before the PAW Committee last week. **AGM Brown** stated that the PAW Committee discussed the topic last week and the Committee requested that the Department submit a report in 30 days on the impact of accepting cash in the field for licenses. **GM Barnett** added that a few years ago City Council enacted a policy that prohibited any department from accepting cash in the field, in effect, this is a policy change. **Commissioner Gross** stated that the topic should be added to the Board's agenda for a future meeting.

5. COMMISSIONERS' ORAL REPORTS AND FUTURE AGENDA ITEMS

Commissioner Finsten: Asked for the department for an update on the trucks and the phones. **GM Barnett** stated that the internal issues with the "ghost" phones that were hanging up on callers were resolved, no were complaints received in the last

two weeks. **Commissioner Finsten** asked if the issue with the “ghost” phones was in the South L.A. Shelter. **GM Barnett** clarified that it was in the West L.A. or West Valley Shelter where the phones were hanging up on callers. South L.A. Shelter’s phones had wiring issues that were resolved. Additionally, the recorded messages are in the process of being updated. **DFO Mark Salazar** reported on the status of the animal transport vans; Fleet Services approved and paid the vendor; the louvers are being built; replacement of the old solid glass panes with vented glass louver windows should begin within the next week or two. It may take six to eight weeks to complete all the vans. The van that was used for demonstration purposes was sent back to the vendor for smoothing rough glass edges, and is now complete. Out of the fleet of 12 vans, 11 remain to be completed. **Commissioner Gross** inquired if the completed van met the specifications in the requirements. **DFO Salazar** confirmed that it did meet the specifications. Additionally, two brand new animal collection vehicles might be ready in the next 30 days. There were delays due to concerns that the air circulation systems could cause direct cross contamination between dogs; the issue was resolved by installing air diffusers. The remaining vehicles may take four to six weeks a piece to complete. The air conditioning system in the new vehicles is one of the strongest in the industry and runs independent of the vehicle’s main air conditioning. **GM Barnett** thanked DFO Salazar for the unplanned presentation.

Commissioner Dicker: Asked for an update on the playgroup program at the shelters. **GM Barnett** reported that there are playgroups in all the shelters and that the focus is on ensuring that all the animals get into playgroups five days a week, best times of day for it, training staff and volunteers to lead the playgroups, and different styles of playgroups.

Commissioner Garcia: Inquired about the status of the proposed app or portal for adopters of shelter pets. **GM Barnett** stated that it is in development.

Commissioner Garcia: Inquired about South L.A. Shelter’s Capacity for Care (C4C) pilot program. **GM Barnett** reported on positive results, a team from U.C. Davis and Head of Shelter Medicine Kate Hurley were consulted. The Department will provide an updated report on the progress of the program.

Commissioner Wolfson: Recommended that the Department to create a public education campaign addressing what to do in the event of dog attack.

Commissioner Gross: Inquired if pet stores and veterinary clinics can be immediately required to maintain and post notices from the Department of Animal Service for public viewing. **GM Barnett** confirmed that pet stores can be subject to the Department’s requirements; however, the Department does not monitor or regulate veterinary clinics. **DCA Lesel** cited California State law as the authority for regulating pet stores, the law may not apply to veterinary clinics. **GM Barnett** suggested that the Department ask veterinarians for voluntary cooperation, especially the veterinarians that accept the Department’s vouchers. **Commissioner Garcia** asked how the process of obtaining cooperation could be sped up. **GM Barnett** offered to include a request to post the Department’s flyers in the next cycle of notices sent to veterinarians, and estimated that there are 17 pet stores in the City, and 50 or more veterinarians that currently accept the Department’s vouchers.

Commissioner Gross: Commented that the Department’s website roster of permits

issued is several years old and should be updated.

6. Board Reports

A. Staff Report – License Canvassing Program Update

DFO Mark Salazar introduced Lieutenant Annette Ramirez, who oversees canvassing and Administrative Citation program, and presented the report. Praised the License Canvassing Program's team of 10 part time canvassers that work to spread the word about licensing, spay/neuter, services available, and the importance of compliance. From June 2015 to March 2017 canvassers visited 114 out of 135 zip codes in the database. 7500 visits were logged in the Chameleon database. Canvassers have issued 7390 citations, an impressive amount for a handful of part time canvassers. **Commissioner Gross** commented that he met some of the canvassers at a special event. **DFO Mark Salazar** confirmed that some of the canvassers attend the Department's special events and are involved in other community service, yet, manage to maintain their numbers during the 20 hours a week that they perform canvassing duties. **Commissioner Gross** pointed out that the numbers for Pacoima were extraordinarily high. **DFO Mark Salazar** confirmed that Pacoima is an area of high need and has been visited repeatedly. **Lieutenant Annette Ramirez** summarized that due to high density in Pacoima there are more violations requiring frequent follow up. **Commissioner Gross** inquired if the number of licenses issued is available. **DFO Mark Salazar** stated that that number is not available. **GM Brown** stated that a special report for the zip code would need to be pulled from the database. **Commissioner Gross** asked for figures on the number of fines. **DFO Mark Salazar** reported that from June 2015 to March 2017 canvassers collected \$75,000, with \$365,000 in administrative citation fines pending collection. The total in administrative fines collected by the Department in that time frame is \$148,000, with \$1,000,059 pending collection. **Commissioner Gross** suggested canvassers distribute printed information on leash laws to the public. **Lieutenant Ramirez** stated that the Department is in the process of developing hand outs on leash laws and proper dog care of laws. Canvassers hand out information on community specific resources for spay/neuter, microchipping, and licensing. **Commissioner Garcia** inquired if spay/neuter vouchers are distributed by canvassers. **Lieutenant Ramirez** confirmed that canvassers provide the voucher applications for the constituent to fill out, and use their phones and printers to issue a voucher sticker. **Commissioner Gross** and **Commissioner Dicker** commended program's staff.

B. Animal Welfare Trust and Animal Sterilization Fund Balances for May 2017

Commissioner Gross focused on expenditures for Shelter Intervention Program and safety equipment. **GM Barnett** recounted that the Board approved a \$40,000 grant to pay intervention groups when they help the public redeem dogs from

shelters. **Chief Accountant** Lilia Liclican stated that the Department paid on reimbursements up to April 2017. **Commissioner Gross** inquired about the phone fusion manufacturing grant for \$11,000. **GM Barnett** clarified that it was a capital improvement request by Interim AGM Louis Dedeaux that may have a different name and can be tracked by requests submitted by operations. **Commissioner Gross** mentioned long term plan based spending decisions versus spending made necessary by unforeseen crisis. **GM Barnett** recounted how the Board arrived at their decision to approve \$40,000 in Department expenditures, prioritization goals, and examples of restricted and unrestricted funds. **Commissioner Dicker** stated that he understands spreadsheets and will familiarize himself with the specifics of this report. **GM Barnett** acknowledged that some of the data requires definition and is not common knowledge; offered to go over some of the different restricted and unrestricted funds with the Board on a future date. **Commissioner Dicker** agreed that an explanation would be helpful. **GM Barnett** drew attention to the last page of the report list, explained that AFE refers to veterinarians participating in the voucher program, and LOA stands for Letter of Agreement. **Commissioner Gross** asked for details on spending on foundations. **GM Barnett** stated that the City's Contract Administration Bureau oversees the contracts; sometimes groups do not use their full allotment or submit their bills in a timely manner. **AGM Brown** stated that the term of the contract is not reflected on the report, may have data on contract terms in a future meeting. Mobile clinics participation is increasing. **Commissioner Gross** inquired if the contracts start in the Fiscal Year. **CA Liclican** stated that contracts might not start on July 1st, however, the Department's annual budget does start on July 1st, and that determines when the Department can process claims for payment within the terms of the contract. **Commissioner Dicker** stated that some extrapolation is possible based on expenditures to date compared to total allotted. **CA Liclican** added that some foundations are behind in submitting their claims and the Department hasn't paid them. **GM Barnett** stated that the groups log surgeries performed in the veterinary portal, however, submission of original documents is required before payment is approved. **CA Liclican** added that the original documents are matched to portal entries before payment is authorized. **Commissioner Gross** inquired about the East Valley Shelter. **GM Barnett** confirmed that East Valley is the Shelter that the Board approved the Western contract for at the last meeting and is scheduled to go before City Council on Friday. **Commissioner Gross** inquired what happens to the unused balance allotted to East Valley Shelter for the contract with Western. **GM Barnett** stated the Department does not forfeit the unused funds; the vendor is only paid for the work they completed. **CA Liclican** stated the emergency equipment was acquired and delivered, except for the military grade radios for the Field Officers. The Canine Influenza vaccines had to be purchased using the Animal Sterilization funds due to the lateness in the fiscal year, Animal Welfare Trust funds will be used next fiscal year. The radios are pending delivery in July or August.

Public Comment:
None

C. Woofstat Report for May 2017

GM Barnett presented the report; noted that most of the shelters are at 89% to 97% Live/Save rate for dogs; slight drop in the overall Live/Save Rate to 84.13% compared to report in April; 6% Live/Save increase over last year's rates for this time of year; kitten season is the main factor in the difference; overall dog and cat euthanasia rate is down 25% for the year. **Commissioner Gross** asked if the report reflects that cat impounds and save rates are up, and euthanasia rates are down. **GM Barnett** confirmed that is correct and credited Department staff, volunteers, and rescue partners for improved Live/Save rates. South L.A. Shelter is an example of improved rates due to the partnership with U.C. Davis. Additionally, intervention groups enlisted shelter visitors to participate in foster programs, especially, the kitten foster program. **Commissioner Gross** commented that volunteer and foster numbers are up. **GM Barnett** discussed foster programs for older dogs. **Commissioner Dicker** asked if there is data on "foster failures" where the foster ends up adopting the shelter animal. **GM Barnett** confirmed that fosters may adopt or return the animal to the shelter; a special report can be run. **Commissioner Gross** remarked that New Hope placements are down. **GM Barnett** stated that it may be due to New Hope's partnership NKLA. **Commissioner Gross** remarked that licensing numbers are down. **GM Barnett** stated that the 1% drop may be due to a processing backlog. **Commissioner Gross** noted that Hearings are up. **Commissioner Wolfson** inquired about Best Friends no-kill target date of July. **GM Barnett** stated that the Department might achieve no-kill by the end of the year; the focus is on maintaining a 90% Live/Save rate. **Commissioner Dicker** stated that the report points to the critical statistic that cat euthanasia is down 16% from last year.

Public Comment:

Phyllis Dougherty: Commented that owner surrender rates are up, and it should be asked how many were from shelter adoptions; shelter adoption numbers should exclude adoptions from rescue groups. **AGM Brown** stated that owner surrender numbers are higher due to animals impounded in Dangerous Animal cases. **GM Barnett** stated that owners in those cases, incorrectly, think they can avoid a hearing by surrendering their animals.

Meeting called to order at 10:04 a.m. Commissioners present were Gross, García, Dicker, Finsten. Commissioner Wolfson was absent. Also present from Los Angeles Animal Services (LAAS) Assistant General Manager (AGM) Dana Brown acting as Board Secretary and Assistant City Attorney (ACA) Dov Lesel. LAAS General Manager (GM) Brenda Barnette was absent attending a professional conference.

Commissioner Gross opened the meeting, introduced staff including newly appointed Board Secretary Johana Moran who was present for her first meeting. Commissioner Gross and provided an overview of the short meeting agenda.

I. ADMINISTATIVE APPEALS

1. Possible Dangerous Animal Case: DA 161244 WLA

Respondents: Linda Faith Drucker and Richard Scott Fineman
West Los Angeles Animal Care and Control: Captain Wendell Bowers
Complaining Witness: Peter Iovino

The Respondents were represented by separate legal counsels. Ms. Drucker was represented by Michael Rotsten and Mr. Fineman was represented by Jill Ryther. Because there were two attorneys with separate arguments, **Commissioner Garcia** indicated that each attorney would be given seven (7) minutes to present to the Board for a total of 14 minutes. The same opportunity would be afforded to the complaining witness. **AGM Brown** provided a brief overview of the case for the Board. **ACA Lesel** provided some direction related to jurisdiction since the animals have been moved to the city of Oceanside. Ms. Ryther indicated that her client should be removed from the case as his dogs were not involved in either biting allegation. Mr. Rotsten stated that there is lack of evidence to show that the Respondents' dog bit the child in the first incident, and alleged that the complaining witness provoked the dog in the second incident. The Attorney Matthew Stoll appeared on behalf of the Complaining Witness Peter Iovino. Mr. Stoll stated that the evidence supports the hearing examiner's determination that Respondents' dog is a dangerous animal, and that Complaining Witness Peter Iovino did not provoke the dog. Lahna Turner, the mother of the child in the first attack allegation, testified on the details of the attack, injuries suffered, and medical treatment received as a result. Janet Iovino, Mr. Iovino's spouse, testified that she witnessed the Respondents' dog walking off leash before, injuries her husband suffered, medical treatment he received, and ongoing physical therapy Mr. Iovino undergoes as a result of the attack. The

Board discussed portions of the testimony and evidence, and asked witnesses to clarify some points. Ms. Ryther maintained that there is no evidence that her client's dogs were involved in either allegation. Mr. Rotsten stated that portions of the evidence are hearsay and the dog should not be deemed dangerous. **Commissioner Garcia** mentioned the history of citations issued for Respondents' dog being off leash. **Commissioner Dicker** inquired if the case should be bifurcated. **Commissioner Gross** stated that it could be looked into, and discussed how to proceed since the Respondents and the dogs have moved out of the City. **Commissioner Dicker** discussed portions of the testimony and evidence. **ACA Lesel** provided guidelines for bifurcation of the case.

Commissioner Dicker motioned to dismiss the case against Mr. Fineman. **Commissioner Gross** seconded the motion and it was approved unanimously by a vote of 4-0.

ACA Lesel informed the Board that if they upheld the General Manager's decision in Ms. Drucker's case, the Department must issue a written notification to the city where the dogs now reside and it is up to that agency to determine what actions they take next.

AGM Brown recounted another dangerous animal case where the department notified another agency, and it led to obtaining cooperation in seizing the animal.

Commissioner Gross motioned to uphold the General Manager's decision. **Commissioner Garcia** seconded the motion and it was approved by a vote of 3-1.

II. REGULAR COMMISSION MEETING

1. PUBLIC COMMENT

Dan Guss: Spoke about kitten foster programs and offered suggestions to improve shelter foster policies; stated spay/neuter laws are not enforced as he witnessed intact dogs off leash in the unfenced park in front of LAPD headquarters; alleged that Interim AGM Dedeaux is hiding animals from rescue groups. **Phyllis Daugherty:** Stated there are flaws with the Department's No Kill plan; stated that a shelter staff member was injured by one of the dogs and the department needs to do more to ensure staff's safety.

2. NEIGHBORHOOD COUNCIL COMMENTS - (Discussion with Neighborhood Council representatives on Neighborhood Council Resolutions or Community Impact Statements filed with the City Clerk which relate to any agenda item listed or being considered on this agenda for the Board of Animal Services Commissioners)

Public Comment:
None

3. ORAL REPORT OF THE GENERAL MANAGER

AGM Brown provided the GM Oral Report in GM Barnette's absence. The only item

reported was a brief update on the intake and foster numbers for the 4th of July weekend. **AGM Brown** indicated that the numbers cover a 7-day period before, during, and after the holiday. Overall, in 2017 there were a total of 1,335 animals received into the shelter, 159 less than the 1,494 from 2016. Also significant were the 215 fosters reported for 2017, 21 more than the 194 reported in 2016. **AGM Brown** commented on the push for fosters during this holiday to make room in the shelters for the influx of animals that come in from being lost during the holiday. Also mentioned was the push in our public relations campaign with social media promotions, press releases, and other events to ready the shelter for the 4th of July holiday.

Commissioner Gross stated that the 4th of July foster program originated in the East Valley Shelter and recognition should go to East Valley ACT Veronica Perry for coming up with the idea. He asked if all the shelters participated in the program this year. **AGM Brown** confirmed. **Commissioner Gross** inquired how many fosters turned into adoptions. **AGM Brown** stated that those numbers are not available; the Department can try to get the information to the Board for a later meeting.

Public Comment:

Phyllis Dougherty: Questioned the statistics of the program and suggested that additional data is needed to determine how effective the program is; feels the temporary arrangements are unfair to the animals and asked the board consider their feelings.

Dan Guss: Submitted an article he wrote about how the City is losing millions in uncollected licensing fees; wants the GM submit a written report; feels that the Department contradicts itself when referring to full shelters; wants an update on the transport vehicle; issues with the voucher program in; commented on delay with new air conditioned animal transport vans.

4. COMMISSIONERS' ORAL REPORTS AND FUTURE AGENDA ITEMS

Commissioner Garcia: Inquired about the effectiveness of the Capacity for Care (C4C) Program. **AGM Brown** stated that an update will be reported at the next Board meeting at the South L.A. Shelter.

Commissioner Finsten discussed the importance of securing working telephones for the shelters and recommended a course of action to ensure prompt resolution.

Commissioner Dicker: Passed.

Commissioner Gross: Inquired how the shelters are coping with the seasonal heat. **Interim AGM Dedeaux** reported on the West Valley Shelter's recent power outage and issues with the power generator; actions taken by him and shelter staff to keep the animals comfortable; aid from the Department of General Services; alternate facility was on standby; and DWP restored power the same night. **Commissioner Dicker** approved of the actions taken by the shelter staff in this incident to ensure the safety of the animals.

Public Comment:

Dan Guss: Commented that the Department should conduct emergency preparedness testing months in advance of anticipated hot weather; accused Interim AGM Dedeaux of misconduct and alleged that elected officials are aware.

Phyllis Dougherty: Thanked Commissioner Finsten for following up on the issue with the telephones in the shelters; spoke about the need for improved emergency preparedness.

Commissioner Gross: Stated that he would like a follow up report on the Department's emergency preparedness plan. Interim AGM Dedeaux agreed to provide a report.

SUMMARY

On August 17, 2016, the Board of Animal Services Commissioners approved a staff recommendation for Capacity for Care (C4C) consultation including purchase and installation of portals at South LA Chesterfield Square. C4C is a management model developed at the University of California at Davis (UC Davis) that helps shelters better meet the needs of the animals in their facilities. It creates the conditions necessary to provide shelter animals with five essential freedoms thereby improving the welfare of individual animals. The five freedoms are Freedom from Hunger and Thirst, Freedom from Discomfort, Freedom from Fear and Distress, Freedom from Pain, Injury or Disease and Freedom to Express Normal Behavior.

After the consultation UC Davis staff submitted recommendations to build a C4C pilot program at the South LA Chesterfield Square shelter. On February 14, 2017, that pilot plan recommendation was considered and approved by the Board of Animal Services Commissioners. The Board report listing the specific elements of the pilot program is attached for your convenience. Since Board approval, efforts have been underway to implement the recommendations made by the UC Davis team. While each of the elements has not been completely implemented, the following has been completed:

- Installation of cat portals - On March 22, 2017, team members from UC Davis installed the 93 purchased cat portals.

- Reduction of age for Spay/Neuter and adoption for kittens to six weeks/1.5 pounds
- Reduction of stray hold to the State mandated 72 hours for cats and dogs without identification
- Removal of required hold for litters

The process is ongoing and additional funds will be required to continue with implementation. Staff will return to the Board with a proposal to allocate funds to complete the pilot program. Estimates are currently being collected for that proposal. The remaining elements of the program involve caging for undersocialized cats, relocation of the rabbits, and the creation of a free roaming cat room.

There was a recommendation made to encourage a managed intake model. One of the chief elements of that recommendation involves removing owner surrender fees. The Department has begun the Council-approval process for that change. Currently the proposal is with the City Attorney's Office awaiting an ordinance update to eliminate the fees.

STATISTICS

During the three month pilot program covering the period from April 1, 2017 to July 1, 2017, South LA Chesterfield Square saw combined dog and cat impounds increase by 104% when compared to impounds from April 1, 2016 to July 1, 2016. Adoptions at South LA Chesterfield Square increase by 132% during the same period.

There is no fiscal impact to the General Fund.

BOARD ACTIONS RECOMMENDED:

APPROVE Implementation of "Capacity for Care" (C4C) recommendations for South LA Chesterfield Square as described herein that resulted from the consultation with UC Davis Shelter Medicine Program.

BACKGROUND:

Capacity for Care is the umbrella term used by the UC Davis Shelter Medicine Program for the combination of providing housing that meets the guidelines for standards of care (and used correctly dramatically decreases cat stress, disease risk, and staff workload), and population/length of stay management practices that will make the housing work to maintain current or better outcomes with fewer housing units available.

South LA Chesterfield Square shelter has been struggling with an inordinate influx of cats and kittens infected with life threatening virus infections known as Feline panleukopenia virus, also known as Feline infectious enteritis, Feline parvoviral enteritis, feline ataxia, feline distemper, or cat plague.

On August 17, 2016, The Board of Animal Services Commissioners approved the staff recommendation to APPROVE "Capacity for Care" (C4C) consultation including purchase and installation of portals at South LA Chesterfield Square for \$30,500 to be funded from the Animal Welfare Trust Fund. It included the Capacity for Care (C4C) Case Studies 2016 update. It involves initial preparation, site visit by three veterinary consultants, installation of 70 portals (in cat cages), and follow up.

RECOMMENDATIONS:

Staff recommendations closely parallel the DRAFT Recommendations for LA City South (attached) with few exceptions. An outline is included here and exceptions are noted.

- I. Implementation of Capacity for Care as a pilot program at this shelter location with objectives of tracking changes, successes and challenges experienced. Depending on the results from this piloted program further implementation at other LA Shelters could be considered.

Cat housing- To the extent possible, these recommendations provide a variety of housing options tailored to the needs of different cats, and will allow the option of presenting cats in a variety of ways to potential adopters.

1. Modify all single stainless steel cages into double compartment housing units where possible
2. Ensure that all cats and kittens are provided a place to hide in their housing unit.
3. Add cat housing to the VIP room for cats and kittens available for adoption.
4. Repurpose the current "unsocialized" Cat room for cat holding and allow the public to enter this room and see cats while on their stray hold.
 - a) Allow people that are interested in adopting to put holds on cats.
5. Repurpose the Cat Isolation to a "Special Care" room for housing cats requiring special care or minor medical treatments.
6. Repurpose the Cat Quarantine room to the Cat Isolation room to only house cats with URI.
7. House unsocial cats outside in the "training" dog kennels.
8. Purchase four larger condos to provide additional larger double compartment housing for cats in the Kitten Room.
9. Purchase one more 4' X 4' cat display unit to provide a cat housing space and cat display for the service lobby area. Items 8 and 9 subject to future approval by the Board if both exceed \$5,000).
10. If further housing is needed in the Cat Room, evaluate use of temporary wire structures for kittens only.
11. In the longer term, consider repurposing the current rabbit room for cat adoptions and identifying other humane housing options for rabbits.

II. Decreasing length of stay (LOS)

In a 3 month pilot program, drop age for Spay/Neuter and adoption for kittens to six weeks/1.5 pounds.

1. Association of Shelter Veterinarians (ASV) Veterinary Medical Care Guidelines for Spay-Neuter Programs supports this practice
2. If pilot is successful after 3 months, expand to all six City operated shelters. Success to be determined by Chief of Veterinary Medicine and the mortality rate of these kittens compared to kittens at eight week/2 pounds.

3. Remove any required hold for litters (two felines under four months of age).
4. Reduce stray hold to the state mandated 72 hours for cats and dogs without identification.
5. Give Animal Care Technician Supervisors (ACTS) more on-the-spot decision making ability to increase live release based on individual cats and the cat shelter population.
6. Allow the public to put adoption holds on dogs and cats while on their stray hold.
7. Use first, second, third, etc. for people who are interested and let them know when they can finalize adoption.
 - a) If all interested parties show up at 8 am on the day the pet is available, hold an auction per our guidelines, **OR**
 - b) If the first person who puts the hold on gets the dog, then the second if the first holder does not show up, etc.
8. Identify cats who are 'slow vs fast track' and begin planning immediately for cats who are at risk such as having New Hope Liaisons notify New Hope Partners and place on RED List.

Prior steps are expected to reduce time to transfer to New Hope Partners and Best Friends.

III. Managing intake-

1. The elimination of owner surrender fee for cats and dogs will be addressed in the 2017-18 budget. The Department recommended eliminating the fee and allowing the person bringing in the animal to make a donation if they wish.
2. Encourage but not require an appointment for surrender through an active marketing program.
3. Work closely with our Intervention Partners to facilitate owner keeping pets when appropriate.
4. Work closely with our Intervention Partners to encourage people who are surrendering to become Foster Volunteers and to continue caring for the dog or cat after we book the animal in as an LAAS animal.

IV. Cost-

If supplies, additional cages or materials are required that exceed a one time cost of \$5,000, a subsequent request for funding from the AWTF will be requested from the Board of Animal Services Commissioners.

We will also publicize the program and seek donations dedicated to this project.

FISCAL IMPACT:

None. We believe that the staff time to properly care for cats will be reduced as well as the
