AGENDAS - The Board of Animal Services Commissioners (Board) meets regularly every second (2nd) and fourth (4th) Tuesday of each month at 9:00 A.M. Regular Meetings are held at City Hall, 200 North Spring Street, Room 1060, in Los Angeles, CA 90012. Evening Meetings are held in various locations throughout the City, from 7:00 to approximately 9:30 P.M. The agendas for Board meetings contain a brief general description of those items to be considered at the meetings. Board Agendas are available at the Department of Animal Services (Department), Administrative Division, 221 North Figueroa Street, 6th Floor, Suite 600, Los Angeles, CA 90012. Board Agendas may also be viewed on the 2nd floor Public Bulletin Board in City Hall East, 200 North Main Street, Los Angeles, CA 90012. Internet users may also access copies of present and prior agenda items, copies of the Board Calendar, MP-3 audio files of meetings as well as electronic copies of approved minutes on the Department's World Wide Web Home Page site at http://www.laanimalservices.com/CommissionAgendas.htm

Three (3) members of the Board constitute a quorum for the transaction of business. Some items on the Agenda may be approved without any discussion.

The Board Secretary will announce the items to be considered by the Board. The Board will hear the presentation on the topic and gather additional information from Department Staff. Once presentations have finished, the Board President will ask if any Board Member or member of the public wishes to speak on one or more of these items. Each speaker called before the Commission will have one (1) minute to express their comments and concerns on matters placed on the agenda. (For certain agenda items, speakers will have two (2) minutes.)

PUBLIC INPUT AT BOARD MEETINGS - Public Participation on Agenda Items. Members of the public will have

an opportunity to address the Board on agenda items after the item is called and before the Board takes action on the item, unless the opportunity for public participation on the item was previously provided to all interested members of the public at a public meeting of a Committee of the Board and the item has not substantially changed since the Committee heard the item. When speaking to an agenda item other than during Public Comment (see Public Comment below), the speaker shall limit his or her comments to the specific item under consideration (California Government Code, Section 54954.3).

Public Comment. The Board will provide an opportunity for public comment at every regular meeting of the Board. Members of the public may address the Board on any items within the subject matter jurisdiction of the Board as part of Public Comment.

Speaker Cards. Members of the public wishing to speak are to fill out one speaker card for each agenda item on which they wish to speak and present it to the Board secretary **before** the item is called.

Time Limit for Speakers. Speakers addressing the Board will be limited to one (1) minute of speaking time for each agenda item except during general public comment period which is limited to two (2) minutes per speaker. (For certain agenda items, speakers will have two (2) minutes each.). The Chairperson, with the approval of a majority of the Board, may for good cause extend any speaker's time by increments of up to one (1) minute.

Brown Act. These rules shall be interpreted in a manner that is consistent with the Ralph M. Brown Act, California Government Code Section § 54950 et seq.

STANDARDS OF CONDUCT. Speakers are expected to behave in an orderly manner and to refrain from personal attacks or use of profanity or language that may incite violence.

All persons present at Board meetings are expected to behave in an orderly manner and to refrain from disrupting the meeting, interfering with the rights of others to address the Board and/or interfering with the conduct of business by the Board.

In the event that any speaker does not comply with the foregoing requirements, or if a speaker does not address the specific item under consideration, the speaker may be ruled out of order, their speaking time forfeited and the Chairperson may call upon the next speaker.

The Board, by majority vote, may order the removal from the meeting of any speaker or audience member continuing to behave in a disruptive manner after being warned by the Chairperson regarding their behavior. Section 403 of the California Penal Code states as follows: "Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is not unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Section 18340 of the Elections Code, is guilty of a misdemeanor."

<u>VOTING AND DISPOSITION OF ITEMS</u> — Most items require a majority vote of the entire membership of the Board (3 members). When debate on an item is completed, the Board President will instruct the Secretary to "call the roll". Every member present must vote for or against each item; abstentions are not permitted unless there is a Conflict of Interest for which the Board member is obliged to abstain from voting. The Secretary will announce the votes on each item. Any member of the Board may move to "reconsider" any vote on any item on the agenda, except to adjourn, suspend the Rules, or where an intervening event has deprived the Board of jurisdiction, providing that said member originally voted on the prevailing side of the item. The motion to "reconsider" shall only be in order once during the meeting, and once during the next regular meeting. The member requesting reconsideration shall identify for all members present the Agenda number and subject matter previously voted upon. A motion to reconsider is not debatable and shall require an affirmative vote of three members of the Board.

When the Board has failed by sufficient votes to approve or reject an item, and has not lost jurisdiction over the matter, or has not caused it to be continued beyond the next regular meeting, the issue is again placed on the next agenda for the following meeting for the purpose of allowing the Board to again vote on the matter.

SUBJECT: REQUEST TO PURCHASE IDENTIFICATION TAGS AND NECESSARY SUPPLIES TO CARE FOR EVACUATED LARGE ANIMALS DURING A DISASTER ON OUR THREE OFF SITE PROPERTIES

BOARD ACTION RECOMMENDED:

APPROVE staff recommendation to use \$6109.50 from the Animal Welfare Trust Fund to purchase nine hundred (900) identification tags and neck ropes from Bock's Identify Company, two hundred (200) buckets and nine (9) rolls of duct tape from General Services (contracted vendor), three (3) first aid kits from Galls Supply (contracted vendor) to identify and care for evacuated large animals at the three off-site properties.

BACKGROUND:

The Department of Animal Services houses large animals on three different site locations, Hansen Dam Equestrian Park, Los Angeles Equestrian Center and Pierce College. There is a need to have equipment and supplies located at these three facilities to more quickly and efficiently identify and care for the animals in our care during a disaster. The supplies along with two canopies and chairs (supplied by Rec & Parks) and other items already purchased will be stored in a Recreation and Parks locked equipment container. The effort in disaster preparedness will allow our staff to report directly to the site and immediately start caring for the animals.

SUMMARY:

Eliminating the time we spend obtaining, organizing and transporting these supplies to the site, will allow staff to quickly begin admitting animals and caring for them. This is an important step in being able to save these animals from a disaster and to keep them warm and isolated during this time, and ultimately providing better service to our communities.






BOARD ACTION RECOMMENDED:

APPROVE Staff Recommendation to add space on LAAS Adoption Agreement for Emergency Contact on Adoption Agreement.

BACKGROUND:

The Department of Animal Services places thousands of companion animals every year. On occasion, the Department picks up or receives a companion animal and we can identify the owner by the microchip or by the license attached to the pet's collar. What is sometimes more difficult is locating the owner to let them know we have their pet. On a few occasions, after the appropriate wait time for the owner to respond to phone calls, emails and a letter, we have adopted out the pet to a new family and the original owner has shown up a few days or weeks later wanting his or her pet back.

SUMMARY:

Staff concurs with Commissioner Wolfson that it would be helpful to have a guardian (Emergency Contact) and their contact information listed on the Adoption Agreement and entered into our animal management database. This information would help staff reunite the pet with his/her family if the pet gets lost. The Emergency Contact would most likely be able to help LAAS contact the owner if the owner cannot be reached and we have their lost pet.

We have used the term "Emergency Contact" because we have not asked the Assistant City Attorney to opine on the use of the term "guardian" to determine if there are any legal definitions or implication such as ownership/responsibility to using the term guardian.
