AGENDAS - The Board of Animal Services Commissioners (Board) meets regularly every second (2nd) and fourth (4th) Tuesday of each month at 9:00 A.M. Regular Meetings are held at City Hall, 200 North Spring Street, Room 1060, in Los Angeles, CA 90012. Evening Meetings are held in various locations throughout the City, from 7:00 to approximately 9:30 P.M. The agendas for Board meetings contain a brief general description of those items to be considered at the meetings. Board Agendas are available at the Department of Animal Services (Department, Administrative Division, 221 North Figueroa Street, 6th Floor, Suite 600, Los Angeles, CA 90012. Board Agendas may also be viewed on the 2nd floor Public Bulletin Board in City Hall East, 200 North Main Street, Los Angeles, CA 90012. Internet users may also access copies of present and prior agenda items, copies of the Board Calendar, MP-3 audio files of meetings as well as electronic copies of approved minutes on the Department's World Wide Web Home Page site at <http://www.laanimalservices.com/CommissionAgendas.htm>

Three (3) members of the Board constitute a quorum for the transaction of business. Some items on the Agenda may be approved without any discussion.

The Board Secretary will announce the items to be considered by the Board. The Board will hear the presentation on the topic and gather additional information from Department Staff. Once presentations have finished, the Board President will ask if any Board Member or member of the public wishes to speak on one or more of these items. Each speaker called before the Commission will have one (1) minute to express their comments and concerns on matters placed on the agenda. (For certain agenda items, speakers will have two (2) minutes.)

PUBLIC INPUT AT BOARD MEETINGS – Public Participation on Agenda Items. Members of the public will have an opportunity to address the Board on agenda items after the item is called and before the Board takes action on the item, unless the opportunity for public participation on the item was previously provided to all interested members of the public at a public meeting of a Committee of the Board and the item has not substantially changed since the Committee heard the item. When speaking to an agenda item other than during Public Comment (see Public Comment below), the speaker shall limit his or her comments to the specific item under consideration (California Government Code, Section 54954.3).

Public Comment. The Board will provide an opportunity for public comment at every regular meeting of the Board. Members of the public may address the Board on any items within the subject matter jurisdiction of the Board as part of Public Comment.

Speaker Cards. Members of the public wishing to speak are to fill out one speaker card for each agenda item on which they wish to speak and present it to the Board secretary **before** the item is called.

Time Limit for Speakers. Speakers addressing the Board will be limited to one (1) minute of speaking time for each agenda item except during general public comment period which is limited to two (2) minutes per speaker. (For certain agenda items, speakers will have two (2) minutes each.). The Chairperson, with the approval of a majority of the Board, may for good cause extend any speaker's time by increments of up to one (1) minute.

Brown Act. These rules shall be interpreted in a manner that is consistent with the Ralph M. Brown Act, California Government Code Section § 54950 et seq.

STANDARDS OF CONDUCT. Speakers are expected to behave in an orderly manner and to refrain from personal attacks or use of profanity or language that may incite violence.

All persons present at Board meetings are expected to behave in an orderly manner and to refrain from disrupting the meeting, interfering with the rights of others to address the Board and/or interfering with the conduct of business by the Board.

In the event that any speaker does not comply with the foregoing requirements, or if a speaker does not address the specific item under consideration, the speaker may be ruled out of order, their speaking time forfeited and the Chairperson may call upon the next speaker.

The Board, by majority vote, may order the removal from the meeting of any speaker or audience member continuing to behave in a disruptive manner after being warned by the Chairperson regarding their behavior. Section 403 of the California Penal Code states as follows: "Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is not unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Section 18340 of the Elections Code, is guilty of a misdemeanor."

VOTING AND DISPOSITION OF ITEMS – Most items require a majority vote of the entire membership of the Board (3 members). When debate on an item is completed, the Board President will instruct the Secretary to "call the roll". Every member present must vote for or against each item; abstentions are not permitted unless there is a Conflict of Interest for which the Board member is obliged to abstain from voting. The Secretary will announce the votes on each item. Any member of the Board may move to "reconsider" any vote on any item on the agenda, except to adjourn, suspend the Rules, or where an intervening event has deprived the Board of jurisdiction, providing that said member originally voted on the prevailing side of the item. The motion to "reconsider" shall only be in order once during the meeting, and once during the next regular meeting. The member requesting reconsideration shall identify for all members present the Agenda number and subject matter previously voted upon. A motion to reconsider is not debatable and shall require an affirmative vote of three members of the Board.

When the Board has failed by sufficient votes to approve or reject an item, and has not lost jurisdiction over the matter, or has not caused it to be continued beyond the next regular meeting, the issue is again placed on the next agenda for the following meeting for the purpose of allowing the Board to again vote on the matter.

BOARD ACTION RECOMMENDED:

APPROVE the use of the Animal Welfare Trust Fund in the amount of up to \$60,000 to host a Volunteer Appreciation Event.

BACKGROUND:

Our Volunteers have been an integral part of our operations for many years. Volunteers complement our staff daily by providing care, attention, and socialization to our dogs, cats, rabbits and other animals. In addition to introducing our customers to companion animals, volunteers also provide other important roles such as photography, grooming, humane education and other tasks. Currently, LAAS has over 1,500 active volunteers who provide over 25,000 hours of support.

SUMMARY:

The LAAS Volunteer Appreciation Event will honor our volunteers for the endless hours of support they provide to our department and our animals. This evening will comprise of a plated dinner, beverages, entertainment, gift bags and special recognition items for those who achieved specific milestones. We anticipate approximately 700 attendees. The AWTF has approximately \$106,000 designated for Volunteer Services and use of these funds will allow us to recognize the outstanding service provided by our volunteers.

**SUBJECT: REQUEST TO APPROVE MUTUAL ASSISTANCE AGREEMENT BETWEEN THE
DEPARTMENT OF ANIMAL SERVICES AND THE COUNTY OF LOS ANGELES**

BOARD ACTION RECOMMENDED:

APPROVE: Staff recommendation to approve the Mutual Assistance Agreement (MAA) between Los Angeles Animal Services Department and the County of Los Angeles.

BACKGROUND:

The County of Los Angeles has utilized this MAA in partnership with the Society for the Prevention of Cruelty to Animals – Los Angeles since September 20, 2011. The Department of Animal Services will be added as an addendum to the original MAA.

SUMMARY:

The MAA provides an arrangement for both agencies to assist one another with the evacuation and sheltering of animals and other animal-related public health, safety and welfare issues resulting from emergencies and disasters. In this partnership with the County of Los Angeles, both agencies agree to furnish personnel, facilities and other resources to render assistance. These efforts to collaborate during emergency circumstances will diminish the depletion of staff and resources of either agency during emergencies. As the County of Los Angeles' boundaries border those of the City's boundaries, this partnership will be advantageous when encountering emergency situations.

FISCAL IMPACT:

There is no fiscal impact.

ANIMAL CARE AND CONTROL MUTUAL ASSISTANCE AGREEMENT

This Animal Care and Control Mutual Assistance Agreement ("Agreement") is made and entered into this 15 day of August 2011, between the County of Los Angeles ("County") and the Society for the Prevention of Cruelty to Animals Los Angeles ("SPCALA").

RECITALS

WHEREAS, the parties have determined that it would be in their best interests to enter into an agreement to implement a plan to assist each other with the evacuation and sheltering of animals and other animal-related public health, safety and welfare issues resulting from emergencies and disasters.

WHEREAS, an agreement to provide mutual assistance is in accord with the California Emergency Services Act, set forth in Title 2, Division 1, *chapter 7* (§ 8550 *et seq.*) of the Government Code and specifically with *article 14* (§ 8630 *et. seq.*) of the Act; and

WHEREAS, no party should be in a position of depleting its own resources, facilities or services to aid another entity.

NOW THEREFORE, the parties hereto mutually agree to use their best efforts to provide assistance as follows:

1. DEFINITIONS:

- a. "Director" shall mean the Director of the County of Los Angeles Department of Animal Care and Control or her/his designee.
- b. "Representative" shall mean the person or persons listed on Attachment A, designated by each party to act on behalf of that party on all matters related to this Agreement, including, but not limited to requests to activate and provide staff, facilities and other resources.
- c. "Emergency" or "Emergencies" shall include fire, earthquake, flood or other natural or man-made emergency.
- d. "Agreement Coordinator" is that person charged with receiving new parties to the Agreement; maintaining a current list of signatory parties and representatives; and circulating annually a list of all parties and Representatives to all signatory parties and arranging for amendments to agreement as may be necessary.

2. **TERM/TERMINATION:** This Agreement shall begin immediately upon execution by the initial parties and shall remain in effect until terminated by agreement of a majority of the parties. Any party may terminate its participation in the Agreement with or without cause, upon the giving of at least sixty (60) calendar days written notice to the other(s).

3. **REQUEST FOR ASSISTANCE:** Assistance may be requested when an emergency has been proclaimed by the governing body of a city, county or city and county or authorized official.
4. **ASSISTANCE TO BE PROVIDED:** Upon request, and without jeopardizing the safety of animals, personnel or property within the jurisdiction of the assisting party, the parties agree to furnish personnel, facilities and other resources and to render assistance to each other as may be necessary to protect and to assist with animal issues affecting the public health, safety and welfare in response to an emergency.
5. **BEST EFFORTS:** Each party shall use its best efforts to provide assistance, but is not required to deplete its own personnel, facilities and other resources. The assistance shall be provided within the limits of the jurisdiction requesting it.
6. **REQUEST FOR ASSISTANCE:** Requests for assistance and authorization to provide assistance shall be made only by the persons listed in Attachment A ("Representatives"), which shall be updated on July 1st of each year. The annual update of representatives does not require the re-execution of the Agreement.
7. **RESOURCE MANAGEMENT:** The requesting party shall be responsible for the safekeeping of the resources provided by the assisting party. The requesting party shall remain in charge of the operations relating to the emergency and shall control and direct the use of the resources provided by the assisting party. Assisting party's personnel shall not be deemed employees of the requesting party and vice versa.
8. **RECORDKEEPING:** The parties shall document and keep accounting records of costs associated with providing assistance, including, but not limited to personnel, equipment, facilities and materials provided.
9. **TERMINATION OF ASSISTANCE:** When the assisting party's personnel, equipment or facilities are no longer required, or when the assisting party's resources are required in its own jurisdiction, the party receiving the services shall immediately arrange for the return of those resources.
10. **INDEMNIFICATION:** The requesting party shall hold harmless, indemnify and defend the assisting party, its officers, agents and employees against all liability, claims, losses, demands or actions for injury to or death of a person or persons or animals, or damages to property arising from or alleged to arise from or as a consequence of this Agreement, provided such liability, claims, losses, demands or actions are claimed to be due to the acts or omissions of the requesting party, its officers, agents or employees or employees of the assisting party, working within the scope of employment and under the direction and control of the requesting party.
11. **DISPUTES:** Any dispute arising from this Agreement is subject to mediation by a mediator selected by the parties.

12. **AMENDMENT:** The parties may agree to review, amend or modify this Agreement at any time. Any amendments to this Agreement must be made in writing and be approved and signed by authorized representatives of all parties.
13. **JURISDICTION:** This Agreement shall be governed by and construed in accordance with the laws of the State of California. This Agreement does not abrogate or waive any immunity available under the Tort Claims Act, the California Emergency Services Act, or any other applicable law.
14. **NOTICES:** All notices required, permitted or desired to be given by one party to the other shall be in writing and shall be delivered to the other party's Coordinator personally, or by United States mail, postage prepaid to the Coordinator at the address identified in Attachment A.
15. **INITIAL PARTIES:** The initial parties to this Agreement are:

PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT relative to the various definitions of kennels.

Recommendations for Council action, pursuant to Motion (Koretz - Blumenfield):

1. REQUEST the City Attorney to prepare and present an Ordinance amending the definition of kennel in Section 12.03 of the Los Angeles Planning and Zoning Code (LAPZC) to specify its application only to kennels maintained for business purposes, with the exception of pet shops (which are separately defined in Section 12.03), and that the definition also be used to resolve any differences in language that exist with the dog and cat kennel definitions in Section 53.00 of the Los Angeles Municipal Code (LAMC), including adding cats if doing so is deemed appropriate and/or useful.
2. INSTRUCT the Department of Animal Services and the Board of Animal Services Commissioners to immediately undertake a public process to make recommendations for the initiation of an Ordinance adding specific per household dog and cat limits to Section 53.00 of the LAMC, amending the dog and cat kennel definitions in Section 53.00 of the LAMC to resolve any differences in language with the proposed revision of the kennel definition in Section 12.03 of the LAPZC, and to ensure that the definition of pet shops in Section 53.00 matches that in Section 12.03, with the intention of having these amendments be considered by the City Council in conjunction with any proposed amendment of the kennel definition in Section 12.03 undertaken as a function of Motion (Koretz - Blumenfield), dated December 13, 2017, and attached to the Council file.


Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Summary:

At a regular meeting held on January 17, 2018, the Personnel and Animal Welfare Committee considered Motion (Koretz - Blumenfield) regarding the definition of kennel. General Manager of the DAS and a representative of the City Attorney's Office clarified to the Committee regarding the term kennel in the various codes. After an opportunity for public comment, the Committee recommended to approve the Motion and request the City Attorney to prepare the Ordinance. This matter is now submitted to the Council for consideration.
