<u>AGENDAS</u> - The Board of Animal Services Commissioners (Board) meets regularly every second (2nd) and fourth (4th) Tuesday of each month at 9:30 A.M. For the duration of the COVID-19 emergency, the Board will meet telephonically and using Zoom software in conformity with the Governor's Executive Order N-29-20 (March 17, 2020). The agendas for Board meetings contain a brief general description of those items to be considered at the meetings. Board Agendas are available at the Department of Animal Services (Department), Administrative Division, 221 North Figueroa Street, 6th Floor, Suite 600, Los Angeles, CA 90012. Once presentations have finished, the Board President will ask if any Board Member or member of the public wishes to speak on one or more of these items. Each speaker called before the Commission will have one (1) minute to express their comments and concerns on matters placed on the agenda. (For certain agenda items, speakers will have two (2) minutes.)

<u>PUBLIC INPUT AT BOARD MEETINGS</u> – Public Participation on Agenda Items. Members of the public will have an opportunity to address the Board on agenda items after the item is called and before the Board takes action on the item, unless the opportunity for public participation on the item was previously provided to all interested members of the public at a public meeting of a Committee of the Board and the item has not substantially changed since the Committee heard the item. When speaking to an agenda item other than during Public Comment (see Public Comment below), the speaker shall limit his or her comments to the specific item under consideration (California Government Code, Section 54954.3).

Public Comment. The Board will provide an opportunity for public comment at every regular meeting of the Board. Members of the public may address the Board on any items within the subject matter jurisdiction of the Board as part of Public Comment. Each speaker will be granted a maximum of two minutes and the presiding officer reserves the ability to extend or limit the time depending on the circumstances of the meeting.

Time Limit for Speakers. Speakers addressing the Board will be limited to one (1) minute of speaking time for each agenda item except during the general public comment period, which is limited to two (2) minutes per speaker (For certain agenda items, speakers will have two (2) minutes each).

Brown Act. These rules shall be interpreted in a manner that is consistent with the Ralph M. Brown Act, California Government Code Section § 54950 et seq.

<u>STANDARDS OF CONDUCT.</u> Speakers are expected to behave in an orderly manner and to refrain from personal attacks or use of profanity or language that may incite violence.

All persons present at Board meetings are expected to behave in an orderly manner and to refrain from disrupting the meeting, interfering with the rights of others to address the Board and/or interfering with the conduct of business by the Board.

In the event that any speaker does not comply with the foregoing requirements, or if a speaker does not address the specific item under consideration, the speaker may be ruled out of order, their speaking time forfeited and the Chairperson may call upon the next speaker.

The Board, by majority vote, may order the removal from the meeting of any speaker or audience member continuing to behave in a disruptive manner after being warned by the Chairperson regarding their behavior. Section 403 of the California Penal Code states as follows: "Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is not unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Section 18340 of the Elections Code, is guilty of a misdemeanor."

<u>VOTING AND DISPOSITION OF ITEMS</u> – Most items require a majority vote of the entire membership of the Board (3 members). When debate on an item is completed, the Board President will instruct the Secretary to "call the roll". Every member present must vote for or against each item; abstentions are not permitted unless there is a Conflict of Interest for which the Board member is obliged to abstain from voting. The Secretary will announce the votes on each item. Any member of the Board may move to "reconsider" any vote on any item on the agenda, except to adjourn, suspend the Rules, or where an intervening event has deprived the Board of jurisdiction, providing that said member originally voted on the prevailing side of the item. The motion to "reconsider" shall only be in order once during the meeting, and once during the next regular meeting. The member requesting reconsideration shall identify for all members present the Agenda number and subject matter previously voted upon. A motion to reconsider is not debatable and shall require an affirmative vote of three members of the Board.

When the Board has failed by sufficient votes to approve or reject an item, and has not lost jurisdiction over the matter, or has not caused it to be continued beyond the next regular meeting, the issue is again placed on the next agenda for the following meeting for the purpose of allowing the Board to again vote on the matter.

4. ORAL REPORT OF THE GENERAL MANAGER

Interim GM Annette Ramirez discussed the following:

- Update on Covid: 28 staff members have been placed off work due to Covid. South LA had 10 cases and East Valley had eight. A request was sent to volunteers for additional support at these facilities. Staff, volunteers, and visitors are required to wear a mask and social distance. Visitors are required to provide proof of vaccination or a negative Covid test. The Department is following the City of Los Angeles Covid-19 workplace safety standards.
- The West Valley volunteer liaison is in training and will officially begin on July 9. The lifesaving liaison for West Valley has been trained and is at the shelter full-time.
- Kennel cards have been placed on both sides of the kennels at West Valley.
- A request has been submitted to General Services to modify the door to the back play yard at West Valley.
- A statue outside of the West Valley shelter was vandalized and a vandalism report was submitted to the Los Angeles Police Department. The Department of Cultural Affairs was also notified so that an insurance claim can be filed to repair the artwork.
- The Department is running low on the canine flu vaccines and it is unknown when we will be receiving more.
- The Department is currently vaccinating for the rabbit hemorrhagic disease and has found that the single dose vaccine works best for the shelter environment. An additional order will be placed in conjunction with San Diego as we have done in the past.
- The Department received funding for two positions to manage the Citywide Cat Program. These positions are currently being advertised and will be filled as soon as possible.
- Adoption discount events will continue through July 8 at all six animal service centers where the Department is offering fee-waived adoptions for the first 250 dogs adopted.
- Staff attended mobile pet adoption events at two different Pet Food Express locations. Two rabbits were adopted and education was provided on how to volunteer and care for animals.
- East Valley shelter hosted a Yappy Hour event for the public to come in and meet dogs that are available for fostering. A couple of dogs did leave with fosters.
- Pet Food Pantry was held on June 12, June 19, and June 26. On June 12, there were 325 pets served at Chesterfield Square, 445 pets served at East Valley and 243 pets served at North Central for a total of 1,013 pets served. On June 19, there were 214 pets served at Chesterfield Square, 477 pets served at East Valley and 293 pets served at North Central for a total of 984 pets served. On June 26, there were 243 pets served at Chesterfield Square, 466 pets served at East Valley and 303 pets served at North Central for a total of 1,012 pets served.
- An update on the license canvasser team will be provided at the next meeting.

- **Michelle Cornelius** asked if the Department was doing a Fourth of July foster program and asked for the procedures to assist the volunteers.

SUBJECT: APPROVAL TO RELEASE TWO REQUESTS FOR PROPOSALS TO PROVIDE PROGRAMS AND SERVICES AT THE JEFFERSON PARK ANIMAL SHELTER AND THE NORTHEAST VALLEY ANIMAL SHELTER

BOARD ACTION RECOMMENDED:

APPROVE the Los Angeles Animal Services (Department) requests to release two Requests for Proposals (RFP) to select one or more experienced animal welfare organization(s) to provide programs and services at the Northeast Valley Animal Shelter and the Jefferson Park Animal Shelter.

BACKGROUND:

Both the Northeast Valley Animal Shelter and Jefferson Park Animal Shelter are currently operated by experienced contractors to provide a range of services that supports and supplements the work done at the six City-staffed Animal Services Centers. Both contracts are set to expire soon and in the interest of continuing these much needed services, the City is seeking to execute new contracts with one or more experienced animal organization(s) to provide services in these locations. The contract for services at the Northeast Valley Animal Shelter, located at 15321 Brand Boulevard, Mission Hills, CA started in December 2011 and is set to expire December 31, 2022. The contract for services at the Jefferson Park Animal Shelter, located at 3612 11th Avenue, Los Angeles, CA started in April 2018 and is set to expire April 26, 2023. The services to be provided will include, but not be limited to: adoption services, low cost spay/neuter surgeries, low cost veterinary services, licensing, educational outreach, and shelter maintenance. Through these RFPs, the Department is looking for one or more operators to continue providing such services.

The Proposers are not to operate these facilities as fully functioning public animal shelters. There will be no intake of animals from the public, no public calls for animal pick up, nor any law enforcement activity. The purpose is to provide the specific services as listed and described in each RFP.

SUMMARY:

The RFPs will allow the Department to contract with one or more experienced animal welfare organizations to provide programs and services at the shelters at no cost to the City.

Upon completion of the RFP processes, the Department will make recommendations to the Board of Animal Services Commissioners on the contract award recipients.

The initial terms of the agreements shall be for three years with three one-year renewal options, exercisable at the City's sole discretion.
